In her assemblage sculptures, **Mike Wright** uses found painted wood and scavenged materials from Provincetown beaches. She was recently awarded the Michael E. Deluty Outstanding Sculpture Prize in the Cambridge (MA) Art Association National Prize Show, and a Full Fellowship at Vermont Studio Center. She was juried into the 2005 Silvermine Arts Center show, the 2004 Cambridge Art Association National Competition, and won second place in the 22nd Annual Juried Exhibition at Custer County Art Museum; she also won the National Competition at Provincetown Art Association and Museum in 1999, which resulted in a solo show. She has exhibited in numerous solo and juried shows in Japan, New York, Baltimore, Louisiana, Montana, the Cahoon Museum of American Art and the Provincetown Art Association and Museum. Her work resides in the permanent collection of the Provincetown Art Association and Museum and in many private collections.
